

Safe School Access and Routing Plan Art City Elementary, Springville, Utah 2016-2017

1. The walking routes on the street system within the school boundaries. (See Map)
 - a. Students living South of Center Street should cross at the established uniform school crossing located at 900 East Center Street.
 - b. Students living North of Center Street to 200 North and East of 900 East should cross at the school crossing located directly in front the main school entrance. There is a painted crosswalk with cones at this location. A faculty member is at this location before and after school.
 - c. Students living North of 200 North and East of 400 East should cross at the painted crosswalks at the 200 North 900 East intersection.
 - d. Students living West of the school should enter from the gate in the West fence or from 200 North or Center Street.

2. The school location:
 - a. Art City School is located at 121 North 900 East. Student may access the school from the east side at 900 East. Students may also enter the school grounds from a walkway in a cul-de-sac located directly West of the school and from a walkway located on the grounds of the adjoining LDS Church.

3. Existing traffic controls
 - a. There are no traffic lights affecting the walking routes at Art City. There are appropriate stop signs at all intersections. The school parking lot is well marked with traffic control signs and the fluorescent green curbs indicate no parking and bus loading zones.

4. Established school crossings
 - a. There is one school crossing with a traffic guard serving Art City School. This is located at 900 East Center.
 - b. There is a painted crosswalk directly in front of the school. We put out warning cones each school day. Faculty members control this crossing before and after school.

5. Loading/unloading areas for bus students & parent drop off area

- a. The parking lot is well marked with signs indicating exits and entrances. All traffic in the school parking lot and bus lane enters from the North and exits to the South. We also utilize the parking lot of the adjacent LDS church. Students stand on the grass planter strip and access vehicles parked in the regular parking stalls. This area is patrolled before and after school by a faculty member.
- b. Bus loading area is well-marked 15 feet from the curb and is patrolled by a faculty member before and after school.
- c. An explanation of the plan.
 - a. This narrative with the map is the explanation of the plan.
- d. Instruction to parents to walk the route with their children
 - a. This narrative is given to parents along with the map. Parents are asked to walk the route with their children to ensure best access from individual homes to the main routes indicated on the plan.
 - b. These instructions are sent home at the beginning of each school year in the information packet given to all families at the School Open House.
- e. Outline of the areas of concern.
 - a. Adequate crosswalks need to be maintained at the following locations:
200 North 400 East, 1300 East Center, 400 South 1300 East, 900 East Center, 121 North 900 East. Hillcrest and 100 South on 800 East, 200 North 700 East, and 700 East Center.
 - b. Adequate sidewalks need to be created and maintained at the corner of 700 East and 200 North. This corner does not contain scooter/bike friendly curb ramps.
